

1	Attendance at school
	Will my child be returning to school in September?
	Yes, your child will return to school full-time in September. The Government issued
	guidance which confirmed their plan that all pupils, in all year groups, will return to school
	full-time from the beginning of the Autumn Term.

	Will my child have to go to school?
	Yes. The usual rules on attendance now apply – school is mandatory again from the autumn
	term.
2	Whole School Approach
	What is the Government's intent and plan for all children to return to school full time from
	the start of September?
	It is based on a twin strategy of limiting contact between pupils and implementing hygiene
	measures (these are described in more detail in section 3(a) (System of controls) below).
	Contact between individuals is to be limited in schools. Contact is to be limited in two main
	ways: 1. By ensuring pupils remain in consistent groups ('bubbles') wherever possible,
	thereby minimising the number of contacts between different people across the school 2.
	By maintaining distance between individuals wherever possible ('social distancing'). Please
	see section below for further details.
	Will Danson be following the Government's intent and plan as outlined above?
	Yes. Danson will be adhering to the Government intent and guidance.
	How will children be grouped?
	The children will be grouped in Year Group Bubbles. These Year Group Bubbles will mean
	we will be able to deliver a full curriculum and operate effectively. E.g. the organisation of
	break times, lunchtimes etc.
	Will those be cocial distancing within bubbles?
	Will there be social distancing within bubbles? The Dff has recognised that strict social distancing will not always be possible, especially
	The DfE has recognised that strict social distancing will not always be possible, especially children will not be able to maintain social distancing, and it is acceptable for them not to
	distance within their group." All schools, in particular primary schools, are encouraged to
	take a realistic and pragmatic approach in this regard. This may include reminding children
	of the need to give each other space where possible; some schools may consider using a
	simple 'no touching' approach to help children understand the need to maintain distance.
	However, the reality is that to fit all pupils in a classroom, they are likely to be in close
	proximity. The DfE has accepted that pupils will need to be sat close to each other in most classrooms (The DfE recommends that pupils sit side-by-side and do not face each other if
	this is possible).

	If older children can maintain social distancing, they will be encouraged to do so. The DfE
	states "for children old enough, they should also be supported to maintain distance and not
	touch staff where possible." If this is possible for older children in primary too, that is to be
	encouraged, but as the DfE has made clear, it is not an essential requirement. The DfE has
	stated that pupils passing each other briefly in a corridor or playground (e.g. walking past



	each other) is a relatively 'low risk', but that schools should try to avoid large groups of pupils mixing together in these spaces at the same time.
	Will the Bubbles be expected to keep away from other Year Group Bubbles? E.g. Will the Y1 Bubble be kept away from Y6 Bubble?
	Yes. We cannot guarantee but will do our very best to ensure Year Group bubbles remain separate from each other at all times.
	Can staff move between Bubbles?
	Yes. The DfE has said that teachers/staff are permitted to move between bubbles. While it is advisable to minimise movement if and where possible, the reality is that this will not always be possible. This also means that sports staff/ Higher Level Teaching Assistants/supply staff can teach across different groups and bubbles.
3	Safety at School
	What protective measures will be in place at Danson?
	We will follow a system of controls which are grouped into 'prevention' and 'response.'

	Are staff going to wear PPE equipment?
	DfE guidance has said that the majority of staff in schools will not require PPE beyond what
	they would normally need for their work. PPE will be needed:
	Where an individual child becomes ill with COVID-19 symptoms while at school
	Where a child has intimate, special or medical care needs
	Where a child requires first aid such as nose bleeds
	Does my child have to wear a face mask?
	The DfE have stated 'Primary school children will not need to wear a face covering.' As we are not medical professionals we will follow the guidance provided and will also leave this decision open to parental choice and subsequent correct behaviour choices of pupils.

The DfE have stated; 'Based on current evidence and the measures that schools are already putting in place, such as the system of controls and consistent bubbles, face coverings will not be necessary in the classroom even where social distancing is not possible. Face coverings would have a negative impact on teaching and their use in the classroom should be avoided.'

Will staff be wearing facemasks?

The DfE have stated, 'In primary schools where social distancing is not possible in areas outside of classrooms between members of staff or visitors, for example in staffrooms, headteachers will have the discretion to decide whether to ask staff or visitors to wear, or agree to them wearing face coverings in these circumstances.' Staff at Danson may require the use of masks in this instance.

What happens if there is a positive case at Danson?

The school will work fully with the health protection team in this situation to guide the school through the actions they need to take.

Current advice-Those who are positive must inform the school and follow the <u>'stay at home: guidance for households with possible or confirmed coronavirus (COVID-19) infection'</u> and must continue to self-isolate for at least 10 days from the onset of their symptoms and then return to school only if they do not have symptoms other than a cough or loss of sense of smell/taste. This is because a cough or loss of smell can last for several weeks once the infection has passed.

What do I do if my child or someone in my household becomes unwell or tests positive for Covid-19?

It is so important that if your child or anyone else in your household becomes unwell or tests positive for Covid-19, they do not come to school and that you notify the school immediately via the school office on 02083031858 or via our new email address C-19queries@danson.bexley.sch.uk.

Anyone presenting with the symptoms of Covid-19; a high temperature, a new continuous cough and a loss of, or change in sense of smell and taste (anosmia) should not attend school and should follow current Government Guidance-*last update* 13th August 2020.

What happens if Danson has to close due to a local outbreak of Covid-19?

The school will work fully with the health protection team in this situation to guide the school through the actions they need to take and share this with parents depending upon the current government guidance issued.

4 Curriculum

What will the curriculum look like?

At Danson, we will not use terms such as catching up or falling behind as these phrases can bring on negative feelings and emotions. We intend to celebrate all our children's achievements during lockdown. We intend to strengthen and consolidate their prior learning and address what our pupils need to help them move forward in their learning journey.



When the children return to Danson in September we have put their well-being at the heart of our curriculum. We understand our pupils will have had different experiences during this time. However, the common thread running through all is the loss of routine, structure, friendship, opportunity and freedom. Many of our children may return to school disengaged, anxious or worried. They may have regressed, lack self-confidence, or feel confused. This is something that we need to immediately address. We want to help our pupils to come back into school life, acknowledging the experiences they have had. We want our children to be happy, feel safe and able to be engaged in their learning. We have decided that a way to achieve this for the children is to acknowledge the importance of helping them get back into school life through using 'recovery conversations' alongside our PHSE/mental wellbeing programme which will provide a scaffold for our children to talk about their experiences and explore the following themes:

A Sense of Community

• Helping pupils reconnect as a school community, recognising the important part each individual plays. Looking at learning behaviours and the school values.

Rebuilding Relationships

Refocusing on friendships and positive relationships within school.

Re-establishing Routines

Ensuring people settle back into school life, adjusting well to necessary changes.

Respecting Space and Social Distancing

• Establishing a 'new normal' in relation to proximity and personal space

Experiencing Loss – Supporting children to manage their feelings and behaviour

Supporting pupils as they struggle to understand their emotions

Excellence and Enjoyment

 Support children to feel they can succeed; fun times focusing on physical health and well-being to rejuvenate positive endorphins and help children want to engage and reignite their passion for learning.

5 In the classroom

Will there be assemblies or any other type of gathering?

We have been advised that there should be no large gatherings bringing different groups together, e.g. whole-school assemblies. However, we will continue to use video assemblies and other resources within the classroom.

Do children in the KS1 and KS2 have to sit in rows facing the front?

The Department for Education's (DfE's) guidance suggests that pupils sit facing the front is one measure schools could take; it is not mandatory. The idea is that by not having pupils facing each other directly (i.e. facing the front instead), it reduces the risk of spreading the virus via respiratory droplets. The school will carry out risk assessments to determine the measures we will put in place to reduce risks.



	Do children in the Early Years have to sit in rows facing the front?
	No. Danson will not be adopting this approach for the Early Years children.
	Can staff still deliver 1:1 interventions with pupils?
	Yes, they can. Staff who are working with pupils across different bubbles are advised to
	take additional precautions. For example, remaining 2m apart if possible and avoiding
	close face-to-face contact and use of visors and screens.
	Will there be school trips?
	There will be no school trips in Autumn term and will be reviewed in January 2021.
6	Structure and Organisation
	Will there be part time rotas in place?
	No. Plans will be based on a full-time provision for our children. However, children will
	have staggered start and finish times to keep different Bubbles apart as they arrive and
	leave Danson. We will aim to ensure that the total amount of teaching time your childre
	receive remains the same e.g. an earlier start would mean an earlier finish.
	What time will school start and end for my child/phase?
	Please refer to documents sent via email on 21.7.2020 and 28.8.2020 for this information
	Alternatively please go to the school website www.danson.bexley.sch.uk
	How will children enter/leave Danson?
	Please refer to documents sent via email on 28.8.2020 for this information.
	Are parents/carers, visitors allowed on site?
	Wherever possible, schools are encouraged to avoid visitors entering their premise
	Therefore, parents/carers will not be allowed on the premises unless they have
	appointment or have been invited into the school. The new EYFS children will be allow
	to have both parent accompany them on their first day only onto in order to support the child starting at Danson. Only one parent should enter the school site to collect their chi with the exception of Reception pupils on their first day at school.
	In instances where we will need to use other essential professionals, such as social worke speech and language therapists or counsellors, or professionals to support the delivery o
	child's education, health and care (EHCP) plan, schools will need to assess whether t professionals need to attend in person or can do so virtually. If they need to attend person, they should closely follow the protective measures in the setting, and the number of attendances should be kept to a minimum. Where possible to do so, social distances
	should be maintained.
	Will my child have a hot meal at lunchtime?
	Not in the first instance upon return to school. Packed lunches will be provided to the children who qualify for Free School Meals, Universal Infant Free School Meals and wish pay for a school dinner. A google form was sent out in July for parents to register the

choice.



Will my child have to wear their school uniform?

Yes, all children must wear their school uniform and appropriate school footwear.

Can my child bring a bag/lunch box to school?

It is recommended that children limit the amount of equipment they bring into school each day to essentials.

Lunchboxes and water bottles only are allowed in the first few weeks and will be reviewed. Please do not send in book bags.

Will the before/during/after school clubs and activities be running in September?

The DfE has stated that ideally schools would keep to the bubbles used during the school day, but recognised this might not be possible. It has stated that "if it is not possible to maintain bubbles being used during the school day, then schools should use small, consistent groups."

Breakfast and After School Club/Sports Clubs will not be running in the first few weeks of the Autumn term. More information will be provided in the first few weeks. Please be patient and bear with us. *Please do not contact the Office until the school has contacted you with further information*.

Use of childminders?

Please ensure your childminder has their own Risk Assessment and is following Government expectations in terms of systems of controls based on age of children in attendance, numbers of children, minimising mixing of families and have a written list of children in each group for at least 21 days for Test and Trace purposes. Should there be suspected case in the childminding bubble then that individual has to self-isolate for 10 days from the commencement of symptoms and testing is encouraged. If the test is positive, all members of the bubbles will have to self-isolate for fourteen days and advice will be sought from PHE for children attending Danson Primary.

Will there be any Parent / Teacher Consultations in the Autumn Term?

We will certainly want to meet with you to discuss your child. However, we will need to work out the best way of doing this either through a virtual platform or face to face and we will advise you during the autumn term. More information will be sent out in due course.
